





## Evaluation Guidelines

### Instructions for Colleges/Departments/Regional Centres/Institutions for Evaluation

1. Nodal Officer will be paid Rs.3500/- (as per approved rates) to supervise the work of online segregating the answer sheets class/subject wise for evaluation by the teachers and send the answer sheets to the Teaching faculty of the College/Departments/Regional Centres/Institutions and keep the record of the same. The bills of the same with **copy of canceled cheque** to be submitted to the Deputy Registrar, Secrecy Branch on the completion of evaluation. (Performa Enclosed 'A').
2. Remuneration to the Checking Assistant will be paid as per University approved rate i.e. Rs.2.50 per answer book. The record of answer-books checked by checking Assistant will be maintained by each Checking Assistant and the bills of the same with **copies of cancel cheque** will be submitted to the Deputy Registrar, Secrecy Branch after the completion of evaluation. (Performa Enclosed 'B')
3. Rates of evaluation of answer books of all Under-Graduate/Post-Graduate examinations are as under:
  - a. Rs 22.00/- per answer book for Under Graduate.
  - b. Rs 27.00/- per answer book for Post Graduate.
  - c. Deduction 5% on account of Teacher Welfare Holiday Home
  - d. Rupee. 1/- entry fee for each exams.
5. All the evaluation bills of the examiners shall be in prescribed Performa only in order to avoid unnecessary delay in processing the bills for payment. (Performa 'C') There is no need to enclose individual evaluator's report with it.
6. Evaluation Bills of Under-Graduate Classes and Post-Graduate classes must be separately made. There shall not be more than 24 Examiners in a single bill.
7. Because of current spike in Covid-19 cases and online mode of evaluation being encouraged, as a special measure masking of roll number is exempted for odd semester examinations December, 2021 (being held in January/February, 2022)
